

ARTICLES OF INCORPORATION

ELORACS Enterprises, Inc.

The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I ~ NAME

The name of the corporation shall be ELORACS Enterprises, Inc.
