The undersigned, acting as incorporator of K.G. PERSONAL TRAINING INC. under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I.**

**NAME**

The name of the corporation is K.G. PERSONAL TRAINING INC. and the principal place of business is: 8520 S.W. 185 Street, Miami, Florida 33157

**ARTICLE II.**

**COMMENCEMENT OF EXISTENCE**

The existence of the corporation will commence on the date of filing of these Articles of Incorporation.

**AUTHORIZED SHARES**
