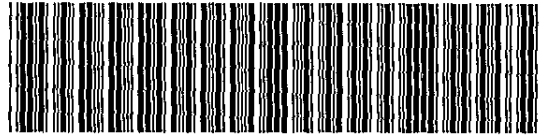

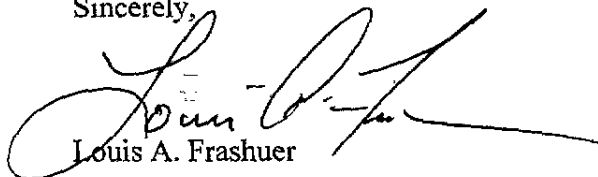

The undersigned incorporator, for the purpose of forming a corporation for profit pursuant to Chapter 621 of the Florida Statutes and laws of the State of Florida, hereby adopts the following Article of Incorporation.

ARTICLE I

NAME

The name of this corporation is LOUIS A. FRASHUER, ATTORNEY-AT-LAW, P.A..

ARTICLE II

DURATION

This corporation shall have perpetual existence effective the earlier of June 1, 2005, or the date of this filing of these Articles with the Florida Department of State.

ARTICLE III

PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business as a Attorney.

ARTICLE IV

CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of Ten Dollar (\$10.00) par value common stock which shall be designated as "Common Shares."

ARTICLE V

RESTRICTION ON OWNERSHIP AND CONTROL OF STOCK

This Corporation may not issue its stock to anyone other than a professional corporation, a professional limited liability company, or an individual who is duly licensed by the Supreme Court of Florida or otherwise legally authorized to practice law as an attorney within the State of Florida.

No shareholder of this Corporation shall enter into a voting trust agreement or any other type of agreement vesting another person with authority to exercise the voting power of any or all of the shareholder's stock.

ARTICLE VI

PRE-EMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation, shall have the right to purchase his pro-rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

ARTICLE VII

INITIAL REGISTERED OFFICE AND AGENT / PRINCIPAL OFFICE

The address of the initial registered office of this corporation is 11038 Fort George Road, Jacksonville, Florida 32226. The name of the initial registered agent at that address is Louis A. Frashuer, Attorney.

ARTICLE VIII

INITIAL BOARD OF DIRECTORS AND OFFICERS

The business of the corporation shall be managed by its Board of Directors. The Board of Directors shall consist of one to two members. The initial Members of the Board of Directors shall be:

INDEMNIFICATION

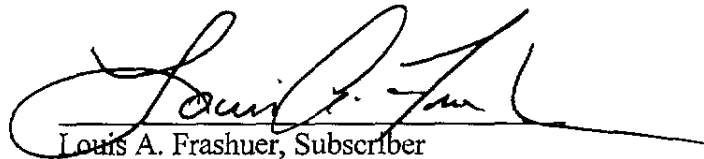
The corporation shall indemnify any Officer or Director or any former officer or director, to the full extent permitted by law.

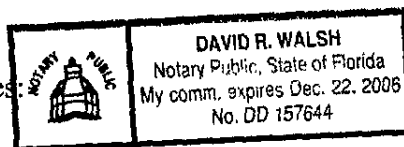

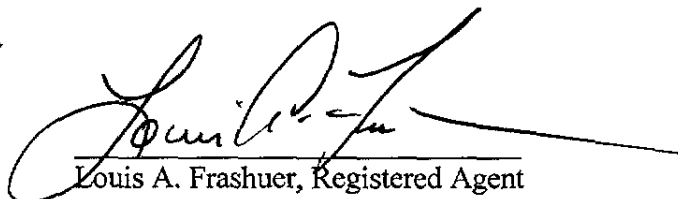
