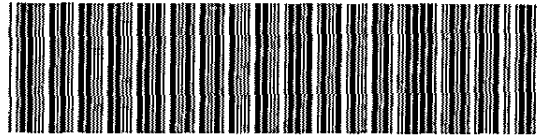

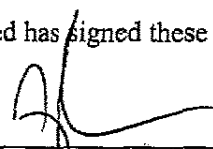
#### **ARTICLE NINE - DURATION**
