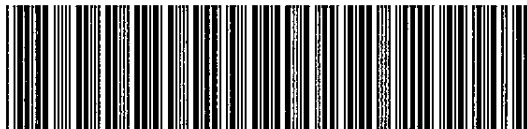



AMENDMENTS


