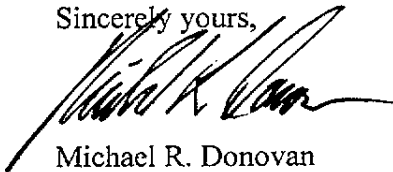

ARTICLES OF INCORPORATION
Of

DEBOND CORPORATION

The undersigned hereby forms a Corporation under the following articles of incorporation.

ARTICLE I - NAME

The name of the corporation shall be: **DEBOND CORPORATION**

ARTICLE II - PRINCIPAL OFFICE

The principal place of business/mailling address is: **11924 FOREST HILL BOULEVARD, SUITE 22-213, WELLINGTON, FL 33414-6258.**

ARTICLE III - PURPOSE

The purpose of the corporation is to engage in any activity of business permitted under the laws of the United States of America or the State of Florida.

ARTICLE IV - SHARES

The corporation shall have authority to issue two classes of Common Stock. Each class of Common Stock shall have the same rights except as described below.

Class A Common Stock: the Corporation shall have the authority to issue five hundred thousand (500,000) shares of common stock with a par value of ten cents (\$0.10) per share. At all shareholder meetings or other meetings at which shareholders are to vote, the holders of this class of stock shall be entitled to one (1) vote for each share of Class A Common Stock owned.

Class B Common Stock: the Corporation shall have the authority to issue five thousand (5,000) shares of common stock with a par value of ten cents (\$0.10) per share. At all shareholder meetings or other meetings at which shareholders are to vote, the holders of this class of stock shall be entitled to one hundred (100) votes for each share Class B Common Stock owned.

ARTICLE V - TERM OF EXISTENCE

The period of this Corporation's existence is perpetual.

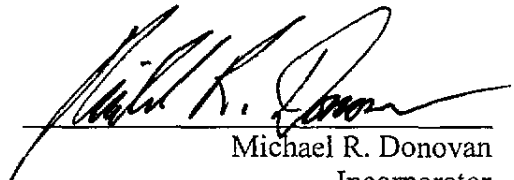
ARTICLE IX AMENDMENT

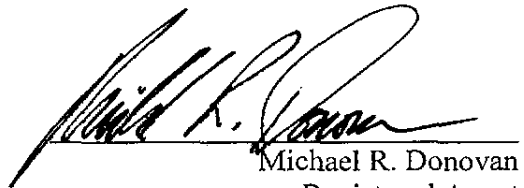
