ARTICLES OF INCORPORATION

OF

SAFEGUARD HEALTH OPTIONS, INC.

<u>ARTICLE I - NAME</u>

The name of this corporation is SAFEGUARD HEALTH OPTIONS, INC., and the mailing address shall be 6794 Jiralda Circle, Boca Raton, Florida 33433.

ARTICLE II - DURATION

This corporation is to exist perpetually unless dissolved according to Florida law.

ARTICLE III - PURPOSE

The general nature of the business to be transacted by this Corporation is to engage in the practice of and to conduct any and all business or other lawful activity permitted under the laws of the State of Florida.

ARTICLE IV - CAPITAL STOCK

- (1) The maximum number of shares of stock that this corporation is authorized to issue to have outstanding at any one time is ONE HUNDRED THOUSAND(100,000) shares of common stock having a par value of ONE CENT (\$.01) per share.
