ARTICLES OF INCORPORATION

OF

KSJW, INC.

ARTICLE I - NAME

The name of this corporation is KSJW, INC., and the mailing address shall be 6794 Jiralda Circle, Boca Raton, Florida 33433.

ARTICLE II - DURATION

This corporation is to exist perpetually unless dissolved according to Florida law.

ARTICLE III - PURPOSE

The general nature of the business to be transacted by this Corporation is to engage in the practice of and to conduct any and all business or other lawful activity permitted under the laws of the State of Florida.
