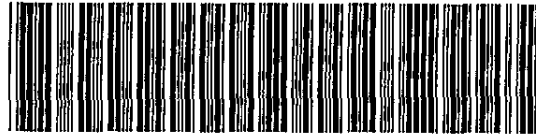

Name**
