





Joseph K. Lustic, the undersigned, does hereby establish for the purpose of becoming a corporation, operating for profit by and under the provisions of the statutes of Florida appertaining and providing for the formation, liabilities, rights, privileges as corporation operating for profit, and do hereby make, subscribe, acknowledge and file these Articles of Incorporation for the purpose of becoming such a corporation for profit and do hereby declare, state and certify:

#### **ARTICLE I**

The name of this corporation shall be:

#### **ARTICLE II**

This corporation shall be effective as of May 10, 2005 and shall have perpetual existence unless sooner dissolved as may be directed by law.
