**ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of North American Business Resource Center, Inc. under the Florida Business Corporation Act, adopts the following articles of incorporation.

ARTICLE I - NAME

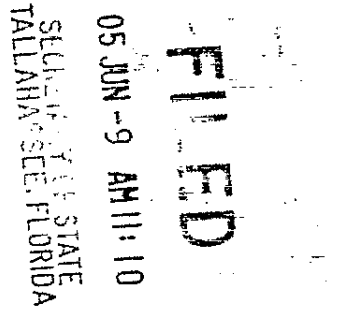

ARTICLE III - COMMENCEMENT OF EXISTENCE

The existence of the corporation will commence on the date of filing these articles of incorporation.

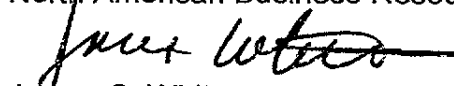
ARTICLE X - AMENDMENTS

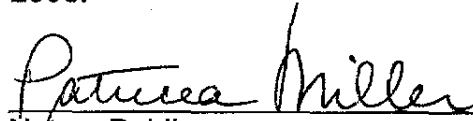

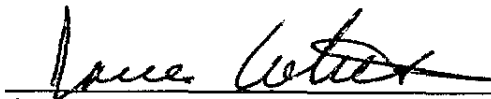
