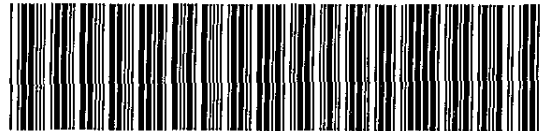

The undersigned, for the purposes of forming a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I  
NAME**

The name of the corporation is ANS CONSULTING, INC.

**ARTICLE II

INDEMNIFICATION**


