Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the Articles of Incorporation of MONISON PALLETS JACKSONVILLE, INC. (the "Corporation") are hereby amended according to theses Articles of Amendment:

FIRST: The name of the Corporation is MONISON PALLETS JACKSONVILLE, INC.

SECOND: Article I of the Articles of Incorporation, as amended, is hereby deleted in its entirety and the following inserted in lieu thereof:

"The name of the Corporation is VMG JACKSONVILLE, INC."

THIRD: The foregoing amendment was adopted by Joint Unanimous Written Consent of the Board of Directors and the Shareholders dated as of July 12, 2005.

FOURTH: Except as hereby amended, the existing Articles of Incorporation of the Corporation shall remain in full force and effect.
