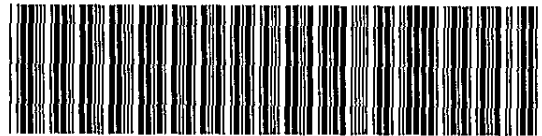



**ARTICLES OF INCORPORATION
OF
ADVANCED BUSINESS COMPUTING SOLUTIONS, INC.**

ARTICLE ONE

The name of the corporation is Advanced Business Computing Solutions, Inc.

ARTICLE TWO

The period of its duration is perpetual. The effective date for the corporation shall be June 15, 2005.

ARTICLE THREE
