The Undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the Laws of the State of Florida.

ARTICLE I.-NAME

The name of the corporation is:

ARTICLE II. – NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be: REPAIR & SERVICE

Any and all activities permitted under the Laws of the United States of Florida.

shall indemnify and hold harmless each person who shall

The rights accruing to any person under the foregoing provisions shall not exclude any other right to which he may be lawfully entitled nor shall anything herein contained restrict the right of the corporation to indemnify reimburse such person in any proper case even though not specifically herein provided for.


#### ARTICLE XI.- PRE-EMPTIVE RIGHTS
