ARTICLES OF INCORPORATION  
OF  
C & R PINE RIDGE, INC.

THE UNDERSIGNED, acting as sole incorporator of a Corporation to be formed under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

FIRST: The name of the Corporation (the "Corporation") is:

C & R Pine Ridge, Inc.

SECOND: The initial principal office or mailing address of the Corporation is:

THIRD: The aggregate number of total shares authorized to be issued by the corporation is Four Hundred (400) to be split between non-voting and voting stock as follows:

A. Non-Voting Common Stock. The aggregate number of non-voting shares that the Corporation is authorized to issue is Two Hundred (200) shares of Non-Voting Common Stock, and no par value.

Except as expressly limited by the Florida Business Corporation Act Chapter 607 of the Florida Statutes, said shares shall have no voting rights in the company. All other rights conferred with respect to distributions (actual, constructive or otherwise), dividends or liquidation proceeds shall be the same as Voting Common Stock.

B. Voting Common Stock. The aggregate number of voting shares that the Corporation is authorized to issue is Two Hundred (200) shares of Voting Common Stock, and no par value


