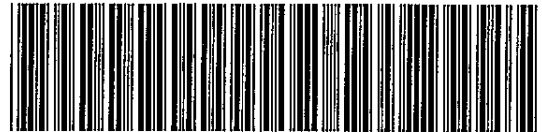



The undersigned subscriber to these Articles of Incorporation, hereby executes these Articles of Incorporation to form a corporation under the laws of the State of Florida.

I. NAME AND MAILING ADDRESS

The name of this corporation is PICKETT BROTHERS PROPERTIES INC., and the mailing address is 11250 Old St. Augustine Road, # 25, Jacksonville, Florida 32257.

II. TERM OF EXISTENCE

This corporation is to exist perpetually.

III. PURPOSE


