1. Pursuant to Florida Statutes Sections 607.1003 and 607.1006, the Officers and Directors of the above referenced Corporation are amended as follows:

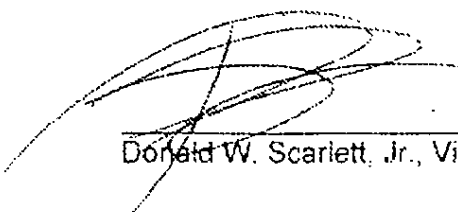
