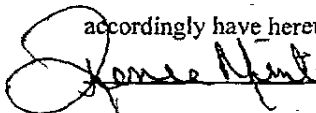
6. Existence.

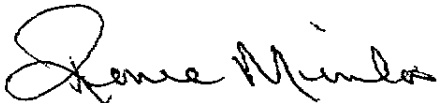
