ARTICLE I

The name of this corporation is DYNAMIC CARPET & RUG WORKROOM, INC. Whose principal address is 5945 S.W. 21st Street Hollywood, FL 33023

ARTICLE II

The general nature of the business to be transacted by this corporation is to engage in wholesale carpet work, a business permitted under the laws of the State of Florida.

ARTICLE III

The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is ONE THOUSAND (1,000) shares of common stock having a par value of ONE DOLLAR (\$1.00) per share.

ARTICLE IV

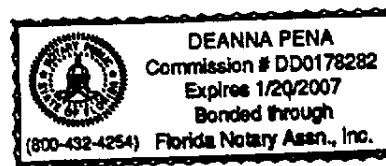
