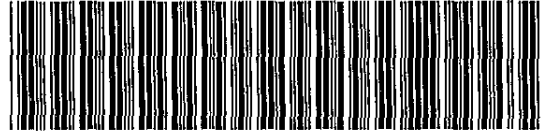

The undersigned hereby makes, subscribes, acknowledges, and files with the Secretary of State of the state of Florida these articles of incorporation for the purpose of forming a corporation for profit in accordance with the laws of the state of Florida.

ARTICLE I

Corporate Name

The name of the Corporation ("Corporation") shall be KSG Consulting, Inc.

ARTICLE II

Powers

The Corporation shall have all powers conferred by the laws of the state of Florida on corporations.

ARTICLE III

Capital Stock

The maximum number of shares the Corporation is authorized to issue is 1,000 shares, par value \$.01 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote. All or any part of the capital stock may be paid for in cash, in property, or in labor or services actually performed for the Corporation.

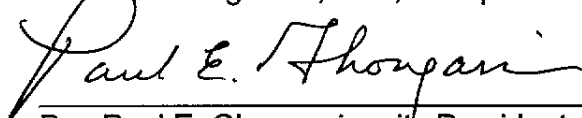

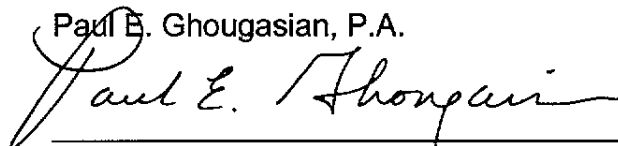
