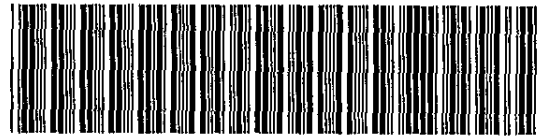

Article I

The name of the corporation is Transaction Mortgage Funding, Inc.

Article II

The corporation is authorized to issue 100 shares of stock at a par value of \$1.00 each. The foregoing voting rights and rights upon dissolution shall occur pro rata according to percentage stock ownership. 


The purpose of the corporation is to engage in any lawful business permitted, and the term of the corporation is perpetual.
