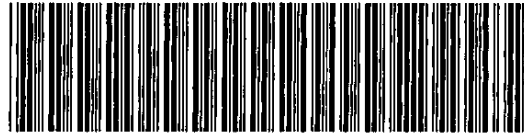

**FIRST:** The name of the corporation as currently filed with the Florida Department of State is **CARSON & WALSH READING GROUP, INC.**


