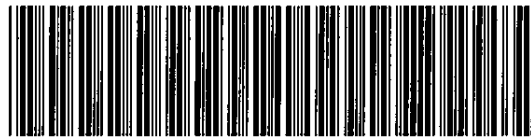

The name of the corporation shall be **SOUTHERN DESIGN LIVING, INC.**


