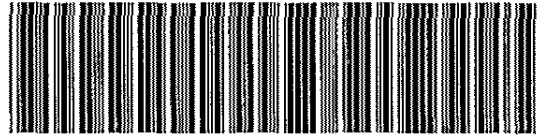

**ARTICLES OF INCORPORATION
OF
R & M SERVICES GROUP, INC.**

The undersigned hereby associate for the purpose of becoming a corporation for profit under the laws of the State of Florida in compliance with Section 607.0202, Florida Statutes.

I.

The Name of the corporation shall be:

R & M SERVICES GROUP, INC.

II.

The principal office of the corporation and the mailing business address of the corporation shall be:

III.

The purpose for which the corporation is to be formed and the general nature of the corporation's business shall be: to engage in the business of repair, service and maintenance of outdoor billboards and other advertisements, as well as to engage in any other activity or business permitted under the laws of the State of Florida.




