This is in reference to your letter of October 7<sup>th</sup> 2008, concerning the 2008 annual report for this corporation.

I called on approx Sept 9 to ask if postmark vs receipt controls this filing of the annual report. The answer was that postmark does control and that the due date was extended until Sept 26<sup>th</sup> 2008 due to the flooding in Central Florida, and the problems that resulted.

My client did try to mail the report by the 26<sup>th</sup> and the postmark should verify this. If the postmark was 27<sup>th</sup> it was not intentional.

I called Tallahassee and was told to contact your office and to return the original 2008 report which is attached.
