

Articles of Incorporation

(In Compliance with Chapter 607 and/ or Chapter 621, F.S (Profit))

<u>OF</u>

OLD CITY STONE INC.

Article I

Name

The name of this corporation is OLD CITY STONE INC.

Article II

Principal Office

The Street Address of the initial principal office of this corporation is 3565 WEST 10TH AVE. OAKLAND PARK, FL 33309. The Board of Directors may, from time to time, change the street and post office address of the corporation as well as the location of its principal office.

Article III

Purpose

This corporation is organized for the following purpose:

1-To engage in any activity or business permitted under the laws of the United States and the State of Florida.

Article IV

Shares (Capital Stock)

This corporation is authorized to issue 100 shares of common stock.

The common stock of the corporation shall have the following characteristics:

- (a) Par Value shall be \$1.00 Per Share.
- (b) At all meetings of the stockholders, the common stockholders shall be entitled to cast one (1) vote for each share of common stock owned. That a common stockholder is interested in a matter to be voted upon shall not disqualify him from voting thereon.
