ARTICLES OF INCORPORATION
OF

The undersigned hereby organizes and subscribes to these Articles of Incorporation under the laws of Florida.

I.

The name of the corporation shall be:

CHRISTIAN J. LARSEN, D.O., P.A.

II.

The specific purpose for which the corporation is organized is to engage in the practice of medicine and shall include the transaction of any or all lawful business for which corporations may be incorporated under Chapter 621, Florida Statutes. The corporations shall have all the powers set forth in Chapter 607, Florida Statutes subject to the limitations as set forth in Chapter 621, as those Statutes are amended from time to time.

III.

The aggregate number of shares of capital stock which the corporation shall have authority to issue shall be 1,000 shares of no par value stock, which stock shall qualify under Section 1244, Internal Revenue Service Code.

V.

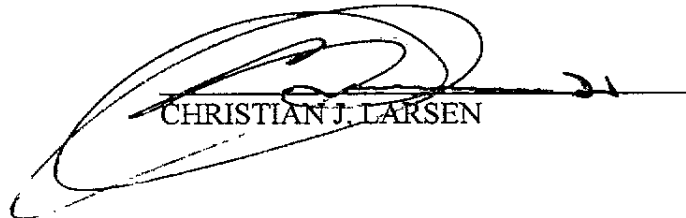
The corporation shall have no Directors and the business of the corporation shall be managed by the stockholders.

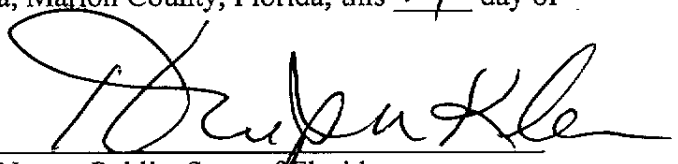
