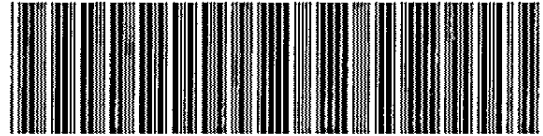

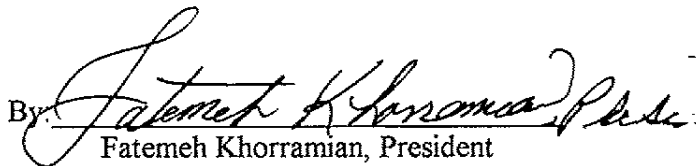

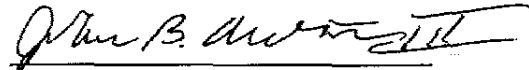

1. ARTICLE I of the Articles of Incorporation of Virtus Ventures, Inc. is amended to read as follows:

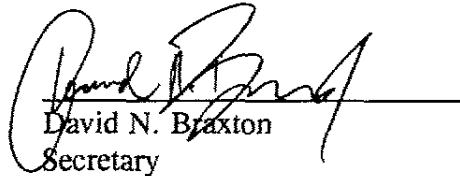
