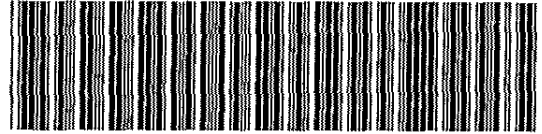

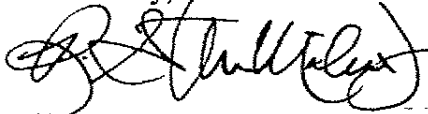

**ARTICLES OF INCORPORATION

In compliance with the requirements of F.S. Chapter 607, the undersigned being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation ("Corporation") is JKTR, Inc..

**ARTICLE II**

The existence of the Corporation shall begin upon the filing of these Articles of Incorporation with the Secretary of State of the state of Florida.

**ARTICLE III**

The street address of the principal office of the Corporation is 813 W. Bryan Street, Kissimmee, FL 34741.

**ARTICLE IV**

The maximum number of shares this Corporation is authorized to issue is 500, par value \$1.00 per share, all of which shall be Common Shares. 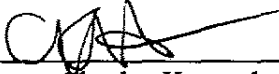

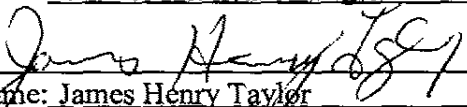
