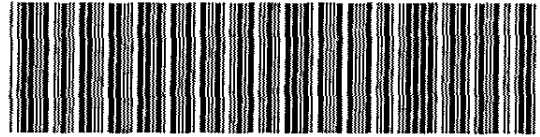



The UNDERSIGNED acting as incorporator of a corporation adopts the following articles of incorporation for such corporation.


1. The name of corporation is **John Fisher, Inc.**
