ARTICLE I-NAME AND ADDRESS

The name of this corporation is GLOBAL CONCRETE PUMPING, INC., located at 3170 SW 138 Avenue, Miami, Florida 33175.

ARTICLE II-DURATION

The corporation shall have a perpetual existence.

ARTICLE III-PURPOSE

The purpose of this corporation is to engage in any activities or business permitted under the laws of the United States of America and the State of Florida.

ARTICLE IV-CAPITAL STOCK


