ARTICLES OF INCORPORATION

<u>ARTICLE I - NAME</u>

The name of the corporation is S&C of Central Florida, Inc., at 702 New Haven Avenue, Melbourne, FL 32901 (Principal Office of Registered Agent).

ARTICLE II - DURATION

This corporation shall exist perpetually, commencing at the time of filing these articles with the Secretary of State of the State of Florida.
