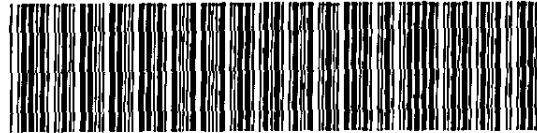



ARTICLE IX


GENERAL PROVISION:


- (e) All share holders of the corporation shall be vested with full preemptive rights.


