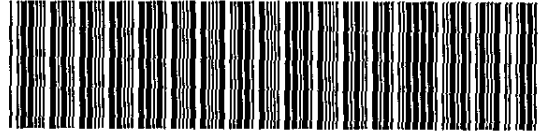

**ARTICLES OF INCORPORATION
OF
FIRE HOUSE STUDIOS, INC**

The undersigned subscribers to these articles of Incorporation, each natural person competent to contract, hereby associate themselves together to form a corporation under the Laws of the State of Florida in compliance with Chapter 607 and/ or Chapter 621, F.S. (profit).

ARTICLE I

The name of the corporation shall be: Fire House Studios, Inc.

ARTICLE II

ARTICLE III

The general nature of the business or businesses to be transacted by this corporation is the following:

1. To own and operate a service business, provide a service of goods, consumer services, retail store, consignment store, or any store or storefront serving the consuming public. To engage generally in the business or ownership and operation of a retail store, consignment store or any store or storefront serving the consuming public for profit.
2. To acquire all real property and equipment necessary to conduct such a business or businesses and to do everything commonly done by those conducting similar business.

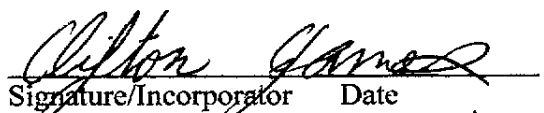

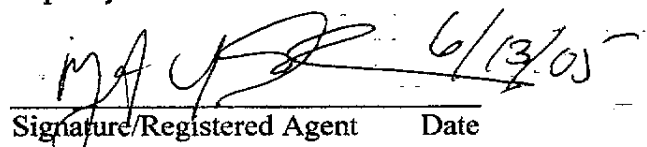
