## ARTICLES OF INCORPORATION OF FIRE HOUSE STUDIOS, INC

The undersigned subscribers to these articles of Incorporation, each natural person competent to contract, hereby associate themselves together to form a corporation under the Laws of the State of Florida in compliance with Chapter 607 and/ or Chapter 621, F.S. (profit).

#### **ARTICLE I**

The name of the corporation shall be: Fire House Studios, Inc.

The general nature of the business or businesses to be transacted by this corporation is the following:
