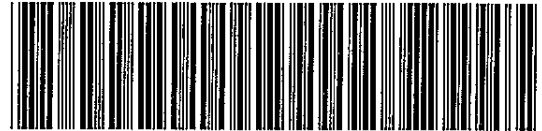

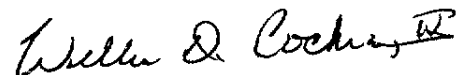

OF

In compliance with the requirements of Chapter 607, Florida Statutes, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Company") is PHASE II TRUCKING, INC.

ARTICLE II

The existence of PHASE II TRUCKING, INC., shall begin on the date of acknowledgment of these articles of incorporation and the street address of the principal office of PHASE II TRUCKING, INC., is 11103 Castle Main Circle South, Jacksonville, Florida 32256.

PHASE II TRUCKING, INC., shall indemnify its directors, officers, employees and agents to the fullest extent permitted by law.

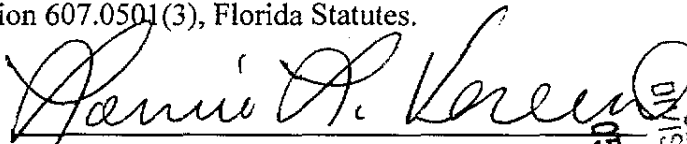
