**I.
Name**

**II.
Term of Existence**

The date when corporate existence will commence is June 19, 2005 in accordance with Section 607.0203(1) of the Act. The Corporation will have perpetual existence thereafter.

**III.
Principal Office**

Capital Stock**

The power to adopt, alter, amend or repeal bylaws will be vested in the Corporation's Board of Directors.


