**ARTICLES OF INCORPORATION
OF
VICKI'S MAILBOX, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

Name of Corporation

The name of this corporation is **VICKI'S MAILBOX, INC.**, and the corporate existence shall commence as of the date of the filing of these Articles of Incorporation.

ARTICLE II

Purposes

The general nature and purpose of business to be transacted, promoted and carried on by the corporation is to engage in packaging and shipping articles via UPS, FedEx, DHL, and U.S. Mail, and such other businesses as may be authorized under the laws of Florida.

ARTICLE III

Principal Office of Corporation

The street address of the principal office of the corporation is 14247 7th Street, Dade City, Florida 33523.

ARTICLE IV

Capital Stock

- a. The maximum number of shares of stock that the corporation is authorized to have outstanding at any time shall be 500 shares of common stock at \$1.00 per share par value. All common shares shall be identical to each other in every respect, and the holders of common shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.
- b. The consideration to be paid for each share shall be payable in lawful money or property, labor or services.

ARTICLE V

Duration

The corporation shall have perpetual existence.

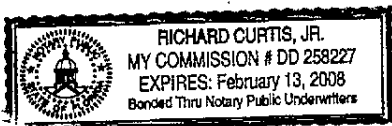


