ARTICLES OF INCORPORATION OF THE BROWNSTONES OF BAY HARBOR, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation is The Brownstones of Bay Harbor, Inc. (hereinafter called the "Corporation").

ARTICLE (I PRINCIPAL OFFICE AND MAILING ADDRESS
