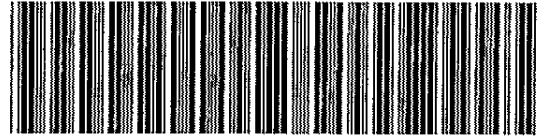

The undersigned incorporator hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I NAME**

The name of the corporation is **Essential Home & Network solutions, Inc.**

**ARTICLE II ADDRESS**

**ARTICLE III COMMENCEMENT OF CORPORATE EXISTENCE**

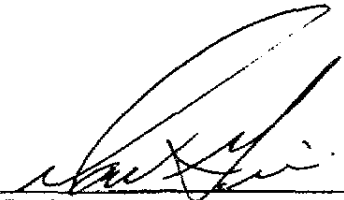

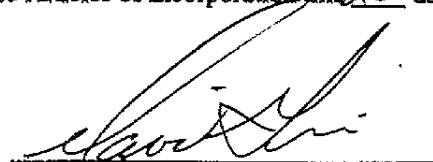
