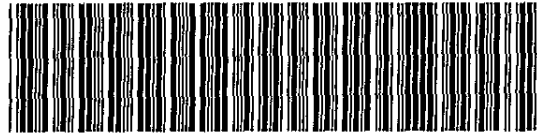


I am making this request because the last time I mailed papers in your office mailed it elsewhere and the people held it forever. PLEASE PLEASE return everything to ME.....
