ARTICLES OF INCORPORATION FOR SWEET DREAMS ANESTHESIA, P.A.

The undersigned attorney at law, on behalf of a natural person, competent and licensed to practice medicine in the State of Florida, acting hereby as Incorporator for the purpose of forming a Professional Service Corporation for profit under the provisions of Section 607, Florida General Corporation Act, of the Florida Statutes, does hereby adopt the following Articles of Incorporation:

NAME OF CORPORATION

The name of the corporation shall be SWEET DREAMS ANESTHESIA, P.A., whose principal office and mailing address is 341 - 4th Avenue South, St. Petersburg, FL 33701.

PURPOSES

The general nature and purposes of business to be transacted, promoted and carried on by the corporation are as follows:

- A. To engage in every aspect in the practice of medicine, and all its fields of specializations, as are engaged by medical doctors.
- B. To engage and render the professional services involved only through its officers, agents and employees who shall be medical doctors in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional service as this corporation.

- D. To engage in no other business other than the rendition of the professional services specified herein.
