ARTICLE L NAME

The name of the corporation is Trova Productions, Inc.

ARTICLE IL DURATION AND COMMENCEMENT OF EXISTENCE

The corporation is to have perpetual existence, commencing at the filing of these articles with the Department of State.

ARTICLE IIL PURPOSE

The corporation is organized for the purpose of managing artistic talents and any and all lawful business.

ARTICLE IV. CAPITAL STOCK
