# ARTICLES OF INCORPORATION

#### ARTICLE I – NAME

The name of this Corporation is: W & J CONSTRUCTION SERVICE INC

#### ARTICLE II - DURATION

This Corporation is to exist perpetually. It shall commence existence on the date of filing of these Articles of Incorporation.

#### ARTICLE III – PURPOSE

This corporation is organized for the purpose of transacting any or all business permitted under the Laws of the United States of America, and the Laws of the State of Florida, and specifically dealing in Residential Construction.

# ARTICLE IV - CAPITAL STOCK

This Corporation is authorized to issue 1,000 shares of common stock at One (1) Dollar par value. Shares may be issued for such consideration as is determined from time to time by the shareholders. This power is reserved unto the shareholders by right and is hereby delegated unto the Board of Directors.
