ARTICLES OF INCORPORATION OF HILLCREST INSURANCE COMPANY

Dooketed by: OPM

The undersigned incorporator(s), all of whom are United States citizens, natural persons, over the age of eighteen (18) years, and competent to contract, hereby form a stock insurance company under the laws of the State of Florida.

ARTICLE I

Name. The name of the Corporation is HILLCREST INSURANCE COMPANY.

ARTICLE II.

<u>Principal Office.</u> The principal place of business shall be in Orange County, City of Orlando, Florida and the physical location and mailing address of this corporation shall be: 4289 Ethan Lane, Orlando, FL 32814. The Corporation may establish and maintain the principal place of business at such other place within the State of Florida as may be determined by the Board of Directors from time to time.

ARTICLE III.

<u>Duration</u>. The period of duration of this Corporation shall be perpetual.

ARTICLE IV

<u>Purpose</u>. The purpose of this Corporation is to engage in any activities or businesses permitted under the laws of the United States, under the Florida General Corporation Act, and to engage in every aspect of property and casualty insurance and reinsurance as permitted under Florida Insurance law and conducting such other business as may be permitted for such an insurance company under applicable law, and the acquisition of life insurance bonds, debentures, commodities, leaseholds, options, puts and calls, easements, mortgages, properties, notes, mutual funds, investment trusts, common trust funds, voting trust certificates, and any class of stock or right to subscribe for stock, including trading on margin.

ARTICLE V

<u>Capital Stock.</u> This Corporation is authorized to issue 100,000 shares of One Dollar (\$1.00) par value common stock. All shareholders shall have preemptive rights in future stock sales by the Corporation. The Corporation shall not begin transacting insurance until it achieves capital and surplus of not less than Five Million Dollars (\$5,000,000), or as required by Florida law.

ARTICLE VI

<u>By-Laws</u>, The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors or Shareholders.

ARTICLE VII

Statutory Agents and Office. The initial registered office of this Corporation shall be 4289 Ethan Lane, Orlando, FL 32814, and the initial registered agent of this Corporation at such office shall be Ernest A. Petrone, who upon accepting this designation agrees to comply with the provisions of Section 48.091, Florida Statutes, as amended from time to time, with respect to keeping an office open to receive service of process from the Treasurer and Insurance Commissioner of the State of Florida.

ARTICLE VIII

<u>Initial Board of Directors.</u> The Corporation shall have five (5) Directors initially, all of whom are United States citizens over the age of 18. The number of Directors may either be increased or diminished from time to time by the By-Laws, but it shall never be less than five.
