ARTICLES OF INCORPORATION OF COLD MOUNTAIN EQUESTRIAN FARMS, INC..



The undersigned, a natural person or persons competent to contract, for the purposes of forming a corporation under the Florida General Corporation Act, do hereby make, acknowledge and file in the Office of the Secretary of State of Florida the following Articles of Incorporation.

ARTICLE I NAME AND ADDRESS:

The name of the corporation is COLD MOUNTAIN EQUESTRIAN FARMS, INC. and its address is 2871 Usina Road, Saint Augustine, Florida 32086.
