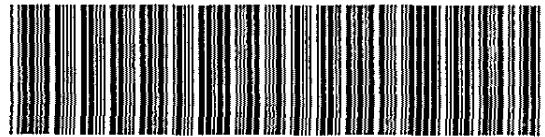

FIRST: Article I is hereby amended to read as follows:

ARTICLE I - NAME

The name of this corporation is **The Law Offices of Steven D. Kramer, P.A.**

SECOND: Article II is amended to read as follows:

ARTICLE II - NATURE OF BUSINESS

The general character or nature of the business to be transacted by this corporation is as follows:

To render the practice of law to the public, which shall consist of consulting and rendering legal advice on any cause or matter whatsoever, including laws, statutes, rules, regulations, contracts, legal principles and other documents or relationships having legal effect; drafting documents and opinions for the purpose of implementing such advice, representation and arrangements; preparing and managing the prosecution or defense of causes in courts or before other tribunals or agencies. This professional corporation shall exist and function with the Professional Service Corporations' Act and in order to properly prosecute the objects and purposes above set forth, the corporation shall have full power and authority to purchase, lease and otherwise acquire, hold, mortgage, convey, and otherwise dispose of all kinds of property, both real and personal, necessary for the rendering of legal services.

THIRD: The date of adoption of this amendment was October 4, 2006.

- **FOURTH:** The amendment was unanimously recommended for adoption by the Board of Directors and unanimously adopted by the shareholders and the number of votes cast was sufficient for approval.
