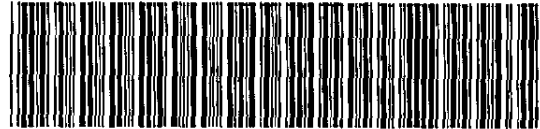

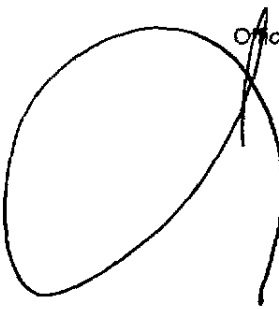

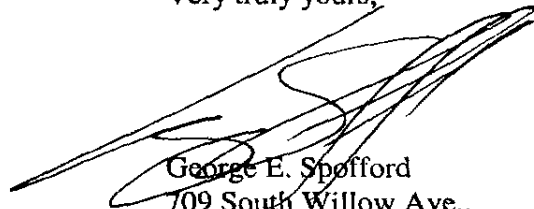

ARTICLES OF INCORPORATION

The undersigned, acting as the incorporator of ABW of Florida, Inc. under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I. NAME

The name of the corporation is: ABW of Florida, Inc.

ARTICLE II. PRINCIPAL OFFICE AND MAILING ADDRESS

The principal business office and mailing address of the corporation is 709 South Willow Ave., Tampa, Florida, 33606.

ARTICLE III. INITIAL BOARD OF DIRECTORS

The corporation shall have two (2) director(s) initially. The number of directors may be either increased or decreased from time to time, as provided in the bylaws. The name and street address of the initial director is:
