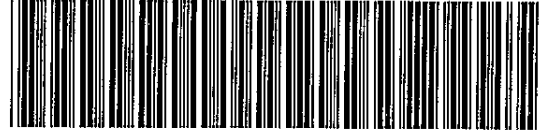

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I- NAME

ARTICLE II- DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State,

ARTICLE III- PURPOSE

ARTICLE IV- CAPITALSTOCK


This corporation is authorized to issue 100 shares of One Dollar (\$1.00) par value common stock which shall be designed as "Common Shares".


